**Committees with Faculty Representation** (reports submitted in advance; please see appendix; this time set aside for elevated issues and/or questions)

1. Academic Policy Committee (Bridget Wadzuk, chair)

Continues to work on the Mininal Use LMS proposal. Will not go into effect until Summer 2026 with the introduction of the new LMS. In response to faculty concerns regarding vagueness in the proposal as well as punitive elements, revisions are under discussion. An APC subcommittee has been created to work with the Vice Provost of Teaching and Learning on the policy.

The new LMS will be should be announced within the next couple weeks

#### **Old Business**

1. Repeat call for faculty members to serve on a 3-year Cabrini Committee (2023-2026) to represent faculty interests in discussions about Cabrini planning—so far we have volunteers from CLAS only (Katie)

Faculty Congress is seeking two to three members per college. Members need not serve on FC.

2. All-faculty FC constitution vote will happen in November or December, 2023 (Katie, Bob Styer)

Constitutional changes that were approved by FC in the spring must be approved by the 2/3 of the all continuining faculty. FC leadership will host a forum to highlight the changes with the hope of holding the vote prior to Thanksgiving.

## **New Business**

1. Proposal to request policy change: extention for age of dependent tuition benefits to age 26 from age 23 (Metin Duran and Sergey Nersesov)

FC explored the prospects of pursuing a policy change for tuition remission, extending the eligibility to age 26. Discussion extended to questions of about expanding this to the tuition exchange as well as including post-graudate studies. FC will compile questions and meet with HR to explore possibilities for expanding coverage.

# **Appendix A: Standing Committee Reports**

# 1. Faculty Rights and Responsibilities Committee

FRRC met on September 5<sup>th</sup> and 21<sup>st</sup> to discuss proposed changes to the FCN College Promotion Committees. The committee eventually voted to not change the eligibility to serve on the college level committees. We would like to see FCN have a tenure and promotion process that is more like other colleges. FRRC have recommended that the college devise a first level review that would act like the department reviews in CLAS, VSB, and Engineering. As in the other colleges, Associate and Assistant Deans could serve on that committee. Then, FRRC would like to shrink the FCN college committees to five members like VSB or 4 like Engineering.

FRRC are meeting on Friday, Oct 6 to work on handbook language for ULC.
